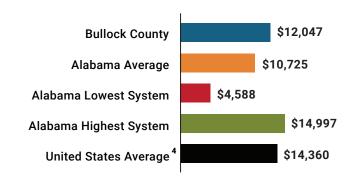

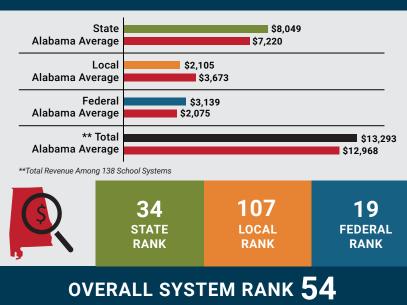

Per-Pupil Revenue Sources

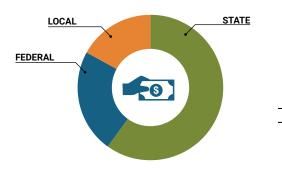
Bullock County Revenue Sources
