Seven years ago, VYJ ventured into the schoolbased Teen Court setting as a means to prevent the school-to-prison pipeline. 
Fair Park opens as a middle school. We implemented Tribal Court, the first school-based peer court in the state of Louisiana.

Raider Court is a schoolbased, student-administered court that hears cases of students who commit minor rule infractions at Huntington High School in Shreveport, Louisiana.

The respondent must admit that he or she is guilty in order to participate in the Raider Court.

RADER COURT What is it?



RADER COURT Objective



The philosophy of Raider Court is to utilize peer pressure as a positive force, help young people accept accountability for their actions while educating respondents and members of the court about the legal system.

It is a goal of Raider Court to create a sense of school pride and community while also creating productive active citizens.

THE RADER LOURT PROCESS

Referrals come from the Assistant Principal and together with the Raider Court Coordinator, they determine which cases would be appropriate for Raider Court.

- The Assistant Principal obtains permission from parent/guardian for student to participate in Raider Court.
- Case is placed on the Raider Court Docket (within 24-48hrs of infraction).
- After hearing the case, notification is sent to Involved Teacher, Assistant Principal, and Principal to inform of outcome of case.
 - Successful Completion or Non-Completion documentation is placed in Student's Discipline File.
 - Court Members follow up with respondents weekly for mentoring, grade checks, and tutoring if needed.

RAIDER COURT: Key Strategies for Ensuring a Restorative Approach

- Train court members to understand that the purpose of a peer court is to repair harm and alter behavior, not to punish.
- Train court members to use strategies that help the respondent understand the effects of their behavior and make amends for that behavior.
- Recognition of respondents completing the sanctions and encouraging respondents to become members of peer court in the future.

RAIDER COURT: Key Strategies for Ensuring a Restorative Approach

- Implement court as a Positive Behavioral Intervention and Support (PBIS), providing a constructive alternative to in and out of school suspension, as well as other disciplinary practices.
- Involve students in decisions that affect them by listening to their views and genuinely taking their opinions into account through juror deliberations.
- Make sure that respondents clearly understand the reasons for the sanctions and what is expected of them.

Then the pandemic happened and everything changed in schools across the country, so we made adjustments to fit the needs of our students.

Many of our students fell behind while participating in virtual learning. When they returned to in-person learning we saw a need to help these students catch up academically.



RAIDER COURT: Peer Tutoring

- Many times, infractions occur in classes in which a respondent is struggling academically.
- Raider Court members offer tutoring in the subject matter the student needs assistance.
- Because the Raider Court members are upper-classmen, they have the experience to offer the freshmen respondents academic help.
- With the tutoring component, 9th grade instructors have seen a visible. improvement in the performance of those struggling students.
- The Raider Court tutoring services are now being utilized by other members of the student body who are not involved in the Raider Court process.



RAIDER COURT: Peer Mentorship

- Raider Court members follow-up with respondents to ensure they are successful in remaining out of trouble.
- Members achieve this by doing weekly check-ins. This includes visiting the respondents' classroom where the infraction occurred.
- Speaking to the teacher to get his/her opinion on how the student is doing in the class since the infraction
- Observing the respondents' interactions with their peers
- Speaking to the repsondents to determine how they are doing and if they need any additional assistance from the Raider Court mentor.

RAIDER COURT: Conflict Resolution/Mediation

- Raider Court members offer Conflict Resolution and Mediation Services to students who the disciplinarian has identified as part of a potential volatile situation that could escalate into a physical altercation.
- Members meet with both groups of opposing parties in order to give voice to the conflict from each group's perspective.
- Members then work to faciliate solutions that both groups agree to implement.
- This peer-led interaction empowers the students to know that they have the power to choose the right solution in resolving conflict.



CULTURE & CLIMATE 2023 - 2024 with Raider Court (1st year without Dr. Mitchell)




Total enrollment at Huntington continues to increase...

THE OVERALL NUMBER OF



RAIDER COURT: Why is it effective?

- Provides positive Peer Pressure and Constructive Consequences
- Focuses on repairing harm to the Victim
- Helps Respondents understand the harm caused by the infraction and builds skills to prevent future infractions
- Avoid Suspension, consequently, keeping students in class to receive valuable instruction time
- Raider Court Members follow-up by serving as peer mentors and tutors to Respondents

RAIDER COURT: Tips for Successful Implementation

- Administrator and staff must buy in to the peer court model.
- Facilitator must have the time in his/her schedule to run the peer court properly.
- Be mindful of when the class is scheduled (certain times of the day could interfere with program success).
- There must be a good relationship/communication between the disciplinarian and the teacher/sponsor.

RAIDER COURT: Tips for Successful Implementation

- Facilitator needs to keep all parties informed of the outcome of the cases (Principal, Assistant Principal over discipline, and the referring teacher).
- There must be thorough follow up by the court facilitator to ensure all sentences are carried out.
- There must be consequences for any non-compliance.
- Members must conduct themselves as leaders on your campus.
- Members must understand the idea of compassion and that we are there to help and not judge.






