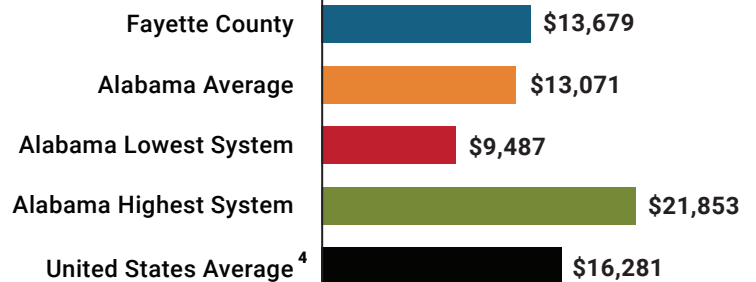

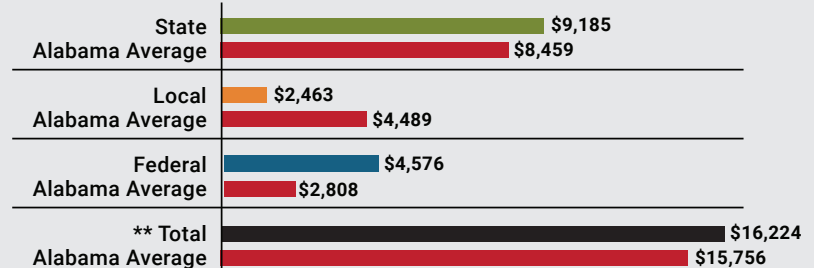

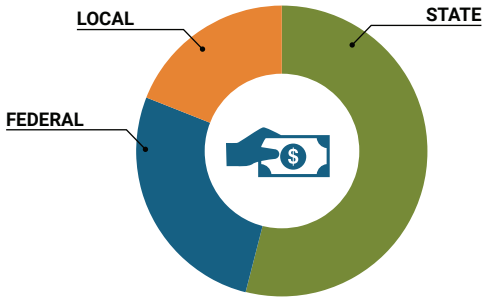
# OVERALL SYSTEM RANK 51

### VALUE OF 1-MILL For Your School System

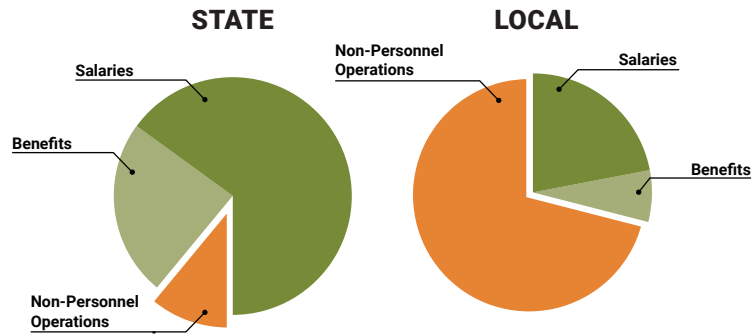

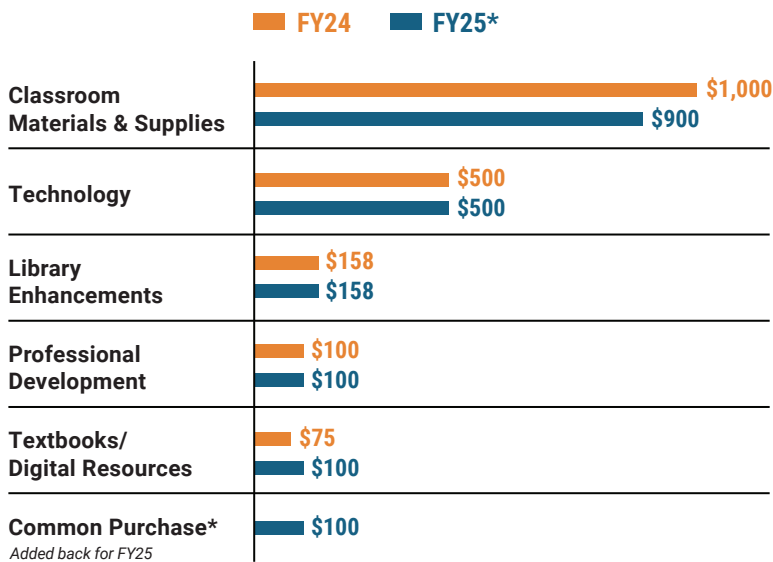

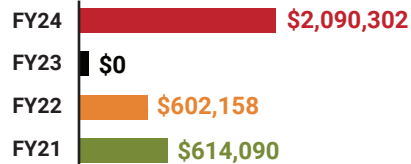
