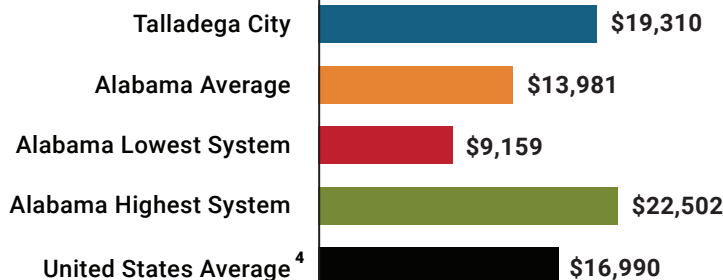

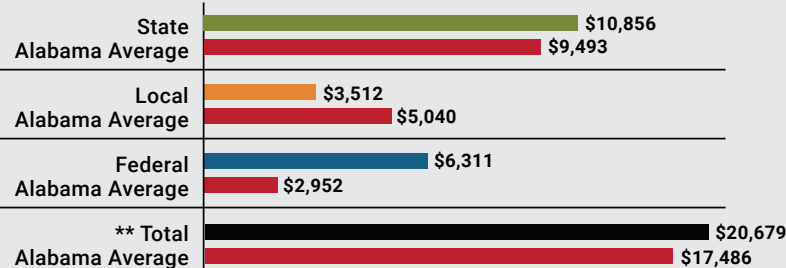

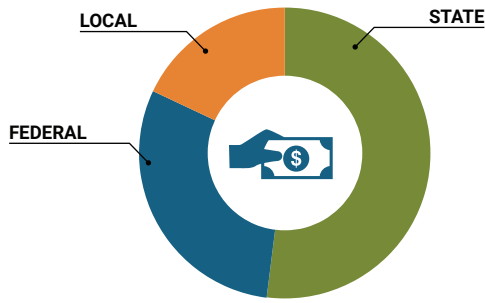
## OVERALL SYSTEM RANK 21

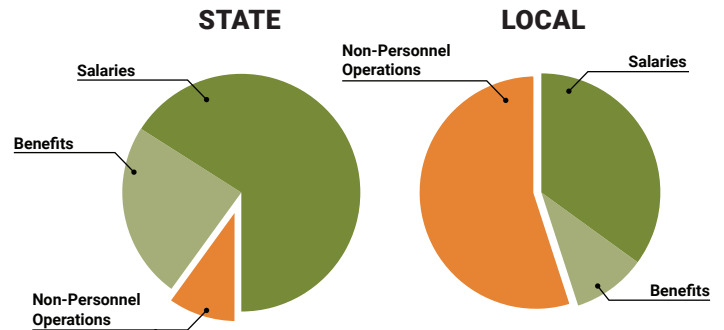

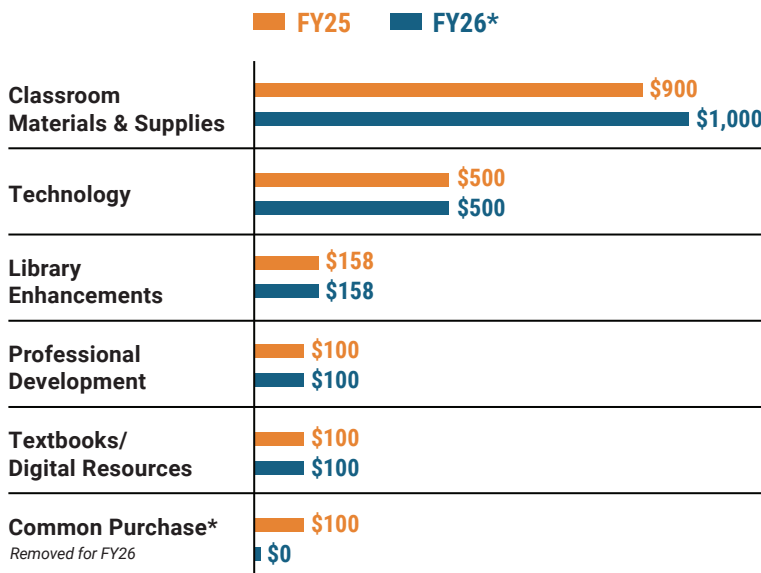
