SBOE Approves Intent to Adopt CCR Indicator as Graduation Requirement

The SBOE voted 6-3 Thursday to announce intent to adopt a new Amended Administrative Code rule that would require a college and career readiness (CCR) indicator to graduate high school beginning in 2028. Gov. Kay Ivey, who serves as president of the board by virtue of her office, told a packed auditorium the time is now to close the gap between the graduation and college and career readiness rates, citing a 92% graduation rate vs. a 76% college & career readiness rate. "It's about closing opportunity gaps and giving kids an opportunity to excel," Ivey said.

The proposed rule will be open for public comment for 45 days with a vote expected in November.

Other board action included amendment adoptions to several Alabama Administrative Code rules, including a rule related to "certain teaching techniques," which will subject educators to the Educator Code of Ethics if found to engage in developmentally inappropriate classroom discussion regarding sexual orientation or gender identity in grades K-5, as passed in the state legislature.

The board work session included an overview of the 2021-2022 ACAP results, an update on the ALSDE's FY24 budget request and a presentation outlining updates special education services.

Important Message to Members Regarding Coverage of Recent AASB District Meeting

A media outlet has been the source of erroneous reporting about AASB's District 5 meeting last Tuesday, and we think it is important AASB members have accurate information.

As part of the Advocacy Update in which AASB Executive Director Sally Smith discussed public schools being in the crosshairs of the culture wars, she referenced an effort by Local Alabama, a grassroots parent group, to collect examples of inappropriate content in Alabama classrooms. She noted she was concerned this group's goal (according to published reports) is to take the examples to the state AG and state BOE instead of local school boards – the entities that could address parental concerns right away. It seems a participant from the District 5 meeting shared this information with a friend who reported it to a media outlet.

The resulting story and spinoff stories state AASB members were told the following (direct quote): "Local Alabama is responsible for disinformation that is leading to a low view of public schools in Alabama." **That statement is a complete fabrication.**

AASB provided this written statement to the outlet and has chosen not to respond to additional requests for interviews because we don't want to give the story more life or lend creditability to the misinformed reports on the meeting. The story and spinoff commentary are being used to create an untrue and unfortunate narrative that local school boards and AASB are critical of parents. This media outlet is also running parallel stories about the survey of school board members by the Alabama Policy Institute, which coincidently owns this media outlet. The stories cite the low participation rate as school boards' "lack of transparency" which should be a concerning to parents.

Contrary to the narrative being pushed in these inaccurate stories, AASB will always advocate for parents, communities and school boards working in partnership for public education and for the important role school boards play in governance of local schools. AASB is in dialogue with Local Alabama and looks forward to working together to address parent concerns.
